**CLEAR HEALTH ALLIANCE HIV/AIDS MEDICAL SERVICES  
EXPANDS INTO BROWARD COUNTY**

Coral Gables, FL. – February 7, 2013 – Clear Health Alliance (CHA), an HIV/AIDS Medicaid specialty plan offered by Simply Healthcare Plans, has received approval from the Agency for Health Care Administration to expand its high quality medical services from Miami-Dade to Broward County.

“Clear Health’s approval to expand access into Broward is critically important for individuals living with HIV and AIDS,” said Marianne Finizio, Executive Vice President, Clear Health Alliance. “Our expertise and knowledge of Medicaid and Medicare, and our ability to coordinate the medical care, social, and behavioral health care needs of HIV and AIDS individuals, meets the increasing demand for services from this population, especially in urban communities.”

Broward County ranks second in the nation for new AIDS cases per capita behind Miami-Dade which ranks first. Palm Beach County ranks sixth in new AIDS cases. Florida ranks third in the nation for the number of persons living with HIV/AIDS.

Approximately \$29 billion is spent annually in the U.S. on HIV/AIDS, with half of all treatments funded by federal and state governments through Medicaid and Medicare. Clear Health Alliance’s expansion to Broward County enables the company to continue to educate and increase awareness about maintaining the health of patients living with HIV/AIDS.
